A. <u>CALL TO ORDER</u>

C. REORGANIZATION OF THE BOARD OF COMMISSIONERS

1. Mayor HARAKAL requested a motion for nomination for President of the Board of Commissioners.

Commissioner WARREN moved to nominate Commissioner SLONAKER.
