**B. PUBLIC HEARING AND VOTING ON ORDINANCES**

1. **BILL NO. 16-2014**

TITLE: AN ORDINANCE AMENDING CHAPTER 15, SECTION 37 OF THE 2006 CODIFIED ORDINANCES OF WHITEHALL TOWNSHIP, ESTABLISHING NO PARKING ZONES 1) ALONG THE WEST SIDE OF QUARRY STREET BETWEEN 120 FEET NORTH OF NORTH STREET & 375 FEET SOUTH TO ITS TERMINUS AND 2) ALONG BOTH SIDES OF NORTH STREET BETWEEN N. FRONT STREET & QUARRY STREET IN THE TOWNSHIP OF WHITEHALL, LEHIGH COUNTY, PENNSYLVANIA. (DEVELOP)

2. BILL NO. 17-2014

TITLE: AN ORDINANCE AMENDING CHAPTER 15, SECTION 38 OF THE 2006 CODIFIED ORDINANCES OF WHITEHALL TOWNSHIP, ESTABLISHING SEASONAL NO PARKING ZONES FOR CERTAIN LOCATIONS & TIMES (FROM NOVEMBER 15 TO APRIL 1) ALONG THE EAST SIDE OF QUARRY STREET BETWEEN 144 FEET NORTH OF NORTH STREET & 395 FEET SOUTH TO ITS TERMINUS IN THE TOWNSHIP OF WHITEHALL, LEHIGH COUNTY, PENNSYLVANIA. (DEVELOP)
