March 9, 2020 Regular Public Meeting

A. CALL TO ORDER

1) The regular Public Meeting of the Whitehall Township Board of Commissioners was called to order at 7:00 p.m. on Monday, March 9, 2020, in the Public Meeting Room of the Whitehall Township Municipal Building, 3219 MacArthur Road, Whitehall, PA, with the following in attendance:

The meeting was formally opened with the Pledge of Allegiance to the Flag and a moment of silence for our troops serving home and abroad.

President GINDER read the statement on fair housing as required.

APPROVAL OF MINUTES

Commissioner MARX moved, seconded by Commissioner WARREN to approve the Minutes of the following meeting:

Seven Commissioners were present and voted "yes", with one correction. Motion carried.

B. COURTESY OF THE FLOOR

Philips ARMSTRONG, Lehigh County Executive of 3151 Brynwood Drive, was present for his yearly visit. Executive ARMSTRONG commented on the following issues: 1) emphasized the necessity for residents completing and returning a census form. Approximately \$2,093 per person is given back to the County; 2) mail in ballots will be available – no more standing in lines to vote; and 3) plan in place for coronavirus and utilizing the CDC recommendations.

Clancy KISTLER (Chairman of Ethics Board) of 890 W. Highland Street. Mr. KISTLER handed out the 2019 year end synopsis. Along with Vice Chairman, Becky Beckwith and Ellen Bennett,

Secretary, advised their main focus is to make people aware that they are available for issues that arise and to follow the procedure of writing up the complaint, forwarding it to Executive Secretary who will then forward it to the Board for review.

Joseph WILFINGER of 293 5th Street advised that the Lehigh Valley is ranked 3rd in the State with poor air quality, thanks to the warehouses and rush hour traffic tie-ups on Route 22. The more carbon that is in the air the slower the jet stream becomes, which stalls weather patterns. He suggested planting more hardwood trees to help mitigate the problem. Mr. WILFINGER also noted a multi-municipality environmental council meeting coming up in Bethlehem.

Kerry Lynn CROSSIN of 4552 Cairo Drive asked the Board to reconsider the recently passed noise ordinance cut-off time of 10:30 pm to 10:00 pm and possibly cutting down the distance of 150 ft. Police Chief MARKS advised the Board that he is aware of the problems in that area and suggested that a visit to the neighbors may be the way to go at this time. If that does not ease the situation, then a revisit of the Ordinance may be necessary.

Mr. CLARK also advised that the relief was granted by the ZHB for the lot size requirement.

H. REPORTS OF PUBLIC OFFICIALS

Commissioner DEE sent condolences to the family of the woman recently killed at the MacArthur & Mechanicsville Road intersection. He also encourages residents to fill out and return the census. Commissioner DEE thanked Executive ARMSTRONG for being present in the community.

Commissioner ATIYEH noted that he recently attended the Twp Park and Recreation Meeting and was informed about the Jefferson Pool repairs that are needed or will be needed in the near future. He also urged people to attend the Special Olympics Event on May 1st which is normally held at Whitehall High School but due to construction will be held at Parkland High School this year.

Commissioner MARX advised that Student Government Day will be May 18th and encouraged anyone who can attended to do so as it is always an enlightening day.

Commissioner SLONAKER has been receiving complaints of the MacArthur & Mechanicsville Road intersection. PennDOT needs to do their improvement of extending the north bound turning lane.

Commissioner FISHER thanked Executive ARMSTRONG for speaking this evening and is glad to hear of the steps the County is taking on the coronavirus situation. He can't emphasize enough on protecting yourself.

Commissioner WARREN stated his concerns with the MacArthur & Mechanicsville Road as well. He also noted the urgency of the sidewalk installation on Mechanicsville Road.

President GINDER thanked Executive ARMSTRONG for being present this evening and for all he does for the Township and at the County.
