A. CALL TO ORDER

1) The Regular Public Meeting of the Whitehall Township Board of Commissioners was called to order at 7:00 p.m. on Monday, October 9, 2023 held at the Whitehall Township Public Meeting Room, with the following in attendance:

President MARX read the statement on fair housing as required.

The meeting was formally opened with the Pledge of Allegiance to the Flag and a moment of silence will follow for our men and woman in uniform and our first responders.

President MARX announced that an Executive Session was held on Monday, October 2, 2023 for legal purposes.

APPROVAL OF MINUTES

Commissioner FISHER moved, seconded by Commissioner GINDER to approve the Minutes of the following meeting:

FIVE Commissioners were present and voted "yes". Motion carried.

B. COURTESY OF THE FLOOR

President Marx announced that there is a 3 minute time limit for comments and it will be strictly adhered to.

Karen POSHEFKO of 3303 Musselman Court thanked the Board for their service to the community. She also advised that there is a national travel website called "ebird.org" and Whitehall is listed.

She then noted an article from Parkland Press regarding South Whitehall meeting on farmland preservation. Lastly, she advised that she reviewed the township's Comprehensive Plan and has some additions/changes she would like to see be made.

Andrea HOAGLAND of 51 Kimmett Avenue noted that her concerns from months ago regarding the Mayor and Tony Cocca have not been addressed. She believes that there is an outdated mindset and believes there needs to be policy changes.

LoriAnn FEHNEL of 3107 N. 3rd Street stated that she was appalled at what has occurred with Andy Roman and commented that she felt his request to attend meetings via zoom was a reasonable accommodation and that he deserved a courtesy phone call before missing the third meeting. She also noted that the municipal building doors not being automated makes it difficult for a person in a wheelchair/scooter to enter the building.

Joni TODESKO of 424 4th Street also noted her displeasure with how the situation was handled with Andy Roman and asked what constitutes an excused absence versus unexcused. She believes that the residents voted him in and that they should have a say on this situation.

Marty KROBOTH of 3617 Park Street voiced his concern with the lack of maintenance at the playgrounds.

SIX Commissioners were present and voting "yes". Motion passed.

F. REPORTS OF PUBLIC OFFICIALS

Commissioner ATIYEH commended Recreation Director Brandon Hibbler on the ongoing work at the Township parks and his communication with the Board. Thanked the volunteers who are members of the committee that selected the firm who will compile the Recreation Comp Plan.

Commissioner FISHER noted that on October 15th the EAC will be conducting Adopt a Highway Cleanup along Front Street starting at 8:30am, reflective vests will be provided. Eagle Scout project in the Parkway has been approved by Council and is moving forward. Productive discussion with Lee Rackus, Vito Gallo and Mayor Harakal with moving forward with EV charging stations and WTICDA is willing to partner with businesses to obtain grant funding.

Commissioner GINDER asked Frank Clark the status of Mechanicsville Road. Mr. Clark advised that PennDOT is not going to require the Township to do an alternate engineering study and plans have been submitted to the design team. Chestnut Street Rail Trail striping and growth cut back still needs to be addressed. When will Fire Services Study be reviewed and Mayor noted it will be done at November's

meeting.

Commissioner SLONAKER noted that the fencing has been started around the detention pond on S. Church Street.

Commissioner WARREN apologized for arriving late as he was stuck in traffic on Route 22. He asked what the SALDO amendment is on the L&L agenda. Attorney Gross explained that it is in reference to sidewalks and after discussion it most likely won't be an amendment. Commissioner Warren also noted that his concern is to sidewalks along MacArthur Road, he would like to see them set back with a buffer. Commissioner GINDER stated that unfortunately over the years, PennDOT has flip flopped with what they want and that's why there is no consistency along that roadway.

President MARX wanted to address the following untruthful statements that have been publicized –

- 1) That the building is not ADA compliant the architects and engineers had the doors tested and they are 100% compliant, as well as having received a certificate of occupancy. He does agree that the doors be automated and that is being looked into by the Deputy Mayor.
- 2) That the Fire Department is not properly funded the Board has never refused an appropriation. Whitehall has the same problem as all other fire departments have and that is volunteerism, unfortunately it is a national problem.

Mayor HARAKAL stated that the Comprehensive Rec & Open Space and the Jefferson Street Feasibility Study has been put together as one process and is moving forward with the award to Herbert Rowland & Grubic. TASA Meeting is moving forward with 36 new parking spaces on Chestnut Street. Long Range Transportation Plan was discussed at LVPC. Commissioner WARREN added that the important intersection of 3rd and Grape Street was added to the list and thanked all who had a hand in making that happen.

Treasurer KOREN advised she submitted the September reports showing the Treasurers Distribution Account, Cash Reimbursement Account as well as the Central Operating balances. She also noted that the correction from last month's report was made and a revised report was sent.
