Commissioner WARREN noted that it was great to see the firefighters recognized for their accomplishments.

- Commissioner SLONAKER asked the status of the LED light issues on Grape St & MacArthur Road. Deputy Mayor MEYERS indicated he met with West Side Hammer and PPL and they advised that the problems are mostly related to underground issues. There are a few that are defective or have fuse issues and are working diligently to fix them.
- Commissioner GINDER asked Executive Secretary to provide a list of openings on all Boards and Commissions.
- Commissioner DUTT updated events at the Senior Center and reiterated on the Awards Presentation.
- Commissioner MARX asked that the Board give their approval on an in-kind donation to the Whitehall High School Theater Group. He thanked Chief Nelson, the Fire Dept. and Whitehall PD for their exceptional duties performed at the Spring Ridge fire. He also Commended the Police Dept on the number of citations issued for last year and noted that their presence is making a difference in the community.
- Commissioner HOWER stated how important it is to support the volunteers of the community as they are doing a great job.
- Mayor HARAKAL comments on the Spring Ridge fire and commended the Public Works

 Dept as well for their help as the roads needed to be salted that evening. He thanked

 Commissioner Marx and Ginder for their notification of the street light issues. The Mayor
 also noted that that he has been speaking with Kay Krapf regarding the LV Dairy,
 Andrew Kleiner of LVDEC regarding partnering with them for their input on funding
 issues, Layne Turner of the County Drug & Alcohol Administrator on their programs,
 Lori Hackett and IBEW regarding high school apprentices and Madison Scarfaro

regarding Marcy's Law which supports victim's advocacy. A full Mayors Report will follow.

President HOWER noted that the Board will be adjourning to an Executive Session.
