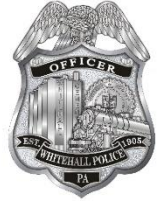

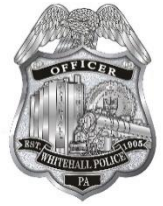

OFFICER STATUS REPORT

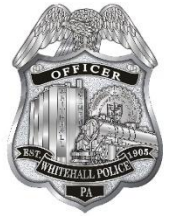

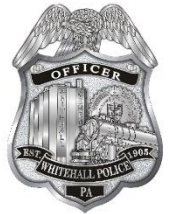

Criminal Investigation Division Report

January 2026

Significant Arrests or Incidents:

The Detective Division assisted patrol with several follow-ups and on-scene incidents.

They also assisted patrol with photo lineups for suspect identifications and identifying suspects in various incidents.

The Detectives had a total of **14** cleared cases and **33** cases assigned between 4 Detectives for this month.

The Whitehall CSPU will be assisting the Lehigh County Accident Investigation Team, in processing scenes outside Whitehall Township. Those crime scene statistics are not included in the monthly report.

The Whitehall Police Crime Scene Processing Unit processed **3** crime scenes this month that consisted of a **Suicide (WH-26-00850)**, **Burglary (WH-26-00773)**, **Suicide (WH-26-01333)**

The Cellebrite analyzer was not used this month.

Arrests

Criminal Mischief

WH-25-13372

Whitehall Police responded to an apartment building for a possible burglary. Upon arrival, damage to the apartment door was discovered but no items inside were missing. The total damage was approximately \$50. The assigned Detective was able to review video from the victim and identify juveniles observed outside of the apartment door between the time frames the victim stated the damage occurred. With the assistance of the victim and School Resource Officers, the juveniles were identified and interviewed where they admitted to the damage. One juvenile was charged with the following as the other juveniles were approved for the impact program:

-Criminal Mischief, Graded as a Summary

Criminal Mischief

WH-25-02183

Whitehall Police responded to the Cementon Park Recreation building for a window that was broken two days in a row by a rock being thrown through it. The scene was processed by a Whitehall Crime Scene Processor where the recovered rock was swabbed for DNA. This swab was brought to the Pennsylvania State Police Lab for analyzation and several months later, the assigned Detective received results from the lab with a match to the DNA swab submitted. The DNA match belonged to a juvenile who Whitehall Patrol Officers had made contact with on the night of one of the broken window incidents. The juvenile was on probation at the time of the incident and was interviewed by the assigned Detective. The juvenile admitted to the broken windows on both nights. The total amount of damage to the window was over \$2,000. The juvenile was charged with the following:

-Criminal Mischief, graded as a Misdemeanor 2

Theft by Unlawful Taking

WH-25-15685 & WH-25-15570

Whitehall Police responded to two separate businesses for damage to air conditioning units and copper wiring and parts missing from the units as well. The assigned Detective was able to obtain video from the area of one of the businesses and was able to observe two subjects on bicycles with one pulling a trailer behind it. Video surveillance was obtained from a local scrap yard and a suspect was developed. This suspect was ultimately involved in a fatal accident and succumbed to his injuries. The second suspect was eventually identified through civilian dashcam and interviews with local residents. The male was interviewed where he admitted he and the other (deceased) suspect were responsible for the damage and theft to the air conditioning units. The total damage/replacement costs to the units were over \$35,000 and the male was charged with the following:

-(2) Counts Criminal Mischief, graded as a Felony 3

-(2) Counts Theft by Unlawful Taking, graded as a Felony 3

Theft by Unlawful Taking

WH-25-15814

Whitehall Police took a report from the victim that his vehicle had been gone through, and items were stolen while it was parked at a local fitness center. The victim reported his iPad, a gun magazine, debit cards and numerous prescription medications were taken from his vehicle. The victim reported his debit card had an attempted withdrawal from a bank branded ATM. The assigned Detective was able to review video surveillance from the fitness center and the location of where the attempted ATM withdrawal occurred. From this, the Detective utilized the license plate readers (LPRs) and a suspect vehicle was developed. Through additional video review and interviews, the Detective was able to identify a suspect, and a warrant was issued for the male. The total value of the stolen items was over \$3,500. The male was charged with the following:

-Theft by Unlawful Taking, graded as a Felony 3

-Receiving Stolen Property, graded as a Felony 3

-Access Device Fraud, graded as a Felony 3

Forgery

WH-26-00091

Whitehall Police took a report from a local jewelry store who reported a male had purchased over \$18,000 worth of jewelry with a fraudulent cashier's check. They also reported the day prior to this; the male completed a credit application but was denied. Approximately 3 weeks after the successful purchase of the jewelry, the store was notified that the check was fraudulent. The store provided the information the male filled out on his denied credit application. The assigned Detective was able to produce a suspect from this information, and a photo line-up was created. The store employee who assisted the male suspect with the purchase, positively identified the male from the photo line-up. The Detective also received information that this same male was involved in an armed robbery in Berks County shortly after our incident. The male is currently incarcerated in Berks County Jail, awaiting transport to Lehigh County to answer to the following charges:

-Forgery, graded as a Felony 2

-Theft by Deception, graded as a Felony 3

-Receiving Stolen Property, graded as a Felony

Forgery

WH-25-11795

Whitehall Police took a report from a local financial institution where a check had been deposited in the amount of \$1,500 by an account holder(suspect). The bank account belonged to was from another financial institution's account holder whose bank account had been hacked and was a victim of an account takeover. This made the \$1,500 check fraudulent. The suspect was contacted by their own bank where they attempted to cash the check, and they gave her the option to pay back the \$1,500 as the bank was now at a loss. The suspect was given 4 months to repay the funds to her bank but failed to do so. The suspect was charged with the following:

-Forgery, graded as a Felony 2

-Theft by Deception, graded as a Misdemeanor 1

-Receiving Stolen Property, graded as a Misdemeanor 1

Burglary

WH-26-00773

Whitehall police responded to the 600 block of Mickley Rd for a burglary report. The victim reported a male was observed entering 3 buildings and the occupied residence without permission. The male was captured on video surveillance, and the victim reported the only

thing missing was a single grocery item from inside the occupied residence. Patrol Officers had previously encountered a male in the same night for an unrelated call who they were able to identify. While reviewing the video surveillance for this burglary call, it was discovered the male in the victim's video surveillance and the male previously encountered by Patrol Officers, were one in the same. An arrest warrant has been filed, and the male has been charged with the following:

- Burglary, graded as a Felony 1**
- Criminal Trespass, graded as a Felony 2**
- Theft, graded as a Misdemeanor 3**

Access Device Fraud

WH-26-00296

Whitehall Police took a report of an unknown person using the victim's debit card without her authorization at a business in the Township. The total amount was approximately \$190, and the victim reported she still had possession of her card. The assigned Detective was able to review transaction statements from the victim and receive video surveillance from the business where the victim's card was utilized. A male suspect could be seen attempting to use multiple cards inside the business, until successful with the victims. Through investigative resources and assistance from other agencies, the Detective was able to positively identify the male and a warrant was issued. The male is currently in Cumberland County Prison on similar charges in Cumberland County and has multiple warrants for him from other agencies for the same type of criminal activity. He was charged with:

- Forgery, graded as a Felony 2**
- Identity Theft, graded as a Misdemeanor 1**
- Access Device Fraud, graded as a Felony 3**

Access Device Fraud

WH-25-15900

Whitehall Police took a report of an unknown person using the victim's debit card without their authorization at various stores in the Township and the Lehigh Valley. The total amount was approximately \$328.16, and the victim reported they still had possession of their card. The assigned Detective was able to review transaction statements from the victim and receive video surveillance from the business where the victim's card was utilized. A male suspect could be seen attempting to use multiple cards inside these businesses, until successful with the victims. Through investigative resources and assistance from other agencies, the Detective was able to positively identify the male and a warrant was issued. The male is currently in Cumberland County Prison on similar charges in Cumberland County and has multiple warrants for him from other agencies for the same type of criminal activity. He is also the same male from the above incident (WH-26-00296)

and is responsible for additional cases where charges will be filed in those cases as well. He was charged with

-Forgery, graded as a Felony 2

-Identity Theft, graded as a Felony 3

-Access Device Fraud, graded as a Felony 3

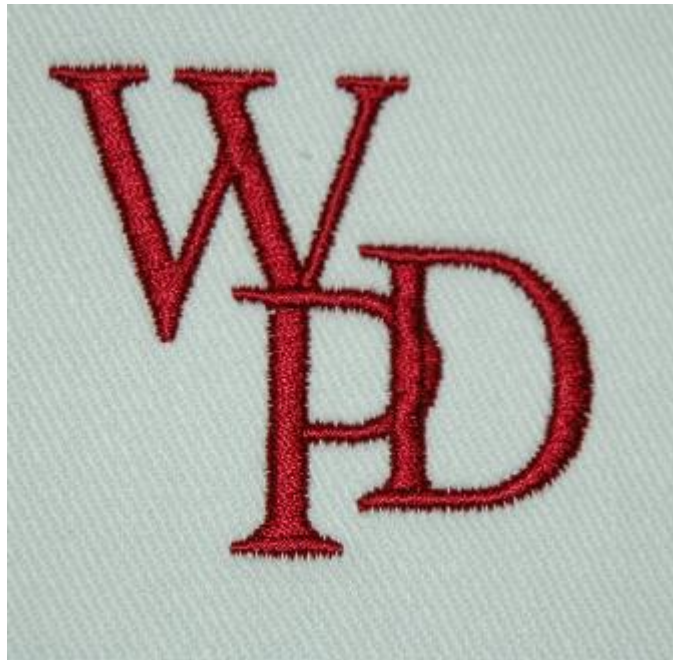
